### **VOTER PHOTO IDENTIFICATION FOR IN-PERSON VOTING**

- 1. A current or expired Georgia driver's license (or Department of Driver Services ID card)
- 2. A valid United States military photo ID card
- 3. A valid photo ID card issued by any branch, department, agency, or entity of the United States, Georgia, or any other state authorized by law to issue personal identification, including a FREE Georgia Voter ID Card
- 4. A valid employee photo ID card issued by any branch, department, agency, or entity of the United States, Georgia, or any county, municipality, board, authority or other entity of Georgia
- 5. A valid United States passport
- 6. A valid tribal photo ID card

**IF THE VOTER DOES NOT HAVE A GEORGIA DRIVER'S LICENSE, OR OTHER QUALIFIED ID**, they can obtain either a FREE Georgia Identification Card from the Department of Driver Services or a **FREE Georgia Voter Identification Card at the Catoosa County Elections and Voter Registration Department**.

In order to get a FREE Georgia Voter Identification Card, a voter will need to provide the following:

- 1. A photo identity document, or a non-photo identity document (must include voter's full legal name and date of birth)
- 2. Documentation showing voter's date of birth
- 3. Evidence that voter is registered to vote in Georgia
- 4. Documentation showing voter's name and address of principal residence

### ACCETABLE DOCUMENTS THAT HAVE VOTER'S PICTURE

- Student ID card
- Government issued license
- Employee ID card
- Government housing authority ID card
- Nursing home ID card
- Transit card
- Pilot's license
- Card accepted by a government to receive benefits or to access a government building

# ACCEPTABLE DOCUMENTS THAT DO NOT HAVE VOTER'S PICTURE ON IT, BUT DO SHOW VOTER'S FULL NAME AND DATE OF BIRTH

- Birth certificate (original or certified copy)
- Voter registration application (available at Catoosa County Elections and Voter Registration Department)
- Naturalization documents
- Federal or state tax return (preceding year)
- Paycheck or paycheck stub (with employer name imprinted)
- Medicare or Medicaid statement (original received by voter)
- Government issued documents (providing reasonably reliable confirmation of voter's identity
- Federal affidavit of birth (Form DS-10)
- Certificate of birth registration
- Court records filed by voter (or on voter's behalf by an attorney)
- Copy of marriage license application
- Hospital birth certificate
- Annual social security statement (original for current or preceding year)

- Certified school record or transcript (current or preceding year)
- Doctor's record of post- natal care (authenticated copy)

## ACCEPTABLE DOCUMENTS THAT SHOW VOTER'S NAME AND PRINCIPAL RESIDENCE ADDRESS

- Voter precinct card
- Valid rental contract (current year)
- Homeowners insurance policy or bill (current or preceding year)
- W-2 (preceding year)
- Utility or cable bill (last 60 days)
- Receipt for rent payments (last 60 days)
- Mortgage, payment coupon, deed or property tax bill (current or preceding year)
- Automobile registration receipt (current year)
- Bank statement (last 60 days)
- Federal or state income tax return (preceding year)
- Homestead exemption documentation

## **ACCEPTABLE DOCUMENTS THAT SHOW VOTER IS A REGISTERED VOTER IN GEORGIA\***

- Voter precinct card
- Voter registration application
