OLD BUSINESS

- City of Ringgold The city street list has been approved. The Intergovernmental Agreement (IGA) between the City of Ringgold and Catoosa County is in the process of being updated.
- City of Ft. Oglethorpe Brownstone and Stone Circle are within the Ft. Oglethorpe city limits. A new city combo
 will be created in the Graysville Precinct; this combo has been submitted to the Secretary of State for approval.
 The Intergovernmental Agreement (IGA) between the City of Ft. Oglethorpe and Catoosa County is in the
 process of being updated.
- Precinct Parking All precinct parking lots have been restriped. The Catoosa County Board of Commissioners
 (BOC) approved funding to study the redesign of the Freedom Center parking lot at the March 21, 2023 meeting.
 The invoice for this study has been sent to the county. The BOC has approved an additional \$30,000 for the
 Freedom Center parking lot improvements and \$20,000 for Chambers parking lot improvements.
- Region Meetings Region Meetings will be held June 22, 2023 (Floyd County (representatives from Reapportionment will speak)); July 20, 2023 (Gordon County); August 17, 2023 (Walker County); and September 14, 2023 (Gordon County). No region meetings will be held in October, November, or December.
- Presidential Preference Primary The Presidential Preference Primary will be held on March 12, 2024.
- Easy Vote Solutions Ron Mckelvy made a motion to purchase the complete Easy Vote Solutions Suite. Debbie Gwaltney made the second. All approved.

- 2024 Budget Ron Mckelvy made a motion to present the proposed Fiscal Year 2024 budget for submission to the county for approval. Debbie Gwaltney made the second. All approved. A budget meeting has been scheduled with the Catoosa County Manager and Chief Financial Officer on June 29, 2023 at 10:00 a.m.

 precinct manager on election day. Managers will be trained in the use of these radios during Poll Manager
 Training.
