Public Comments

- Christine Lawson provided 4 documents for the Board
 - Conflict of interest Rule 1.7 concerned the BOE is getting bad legal advice, advising both BOC and BOE with the BOE being decision-makers
 - The hearing last week violated OCGA 50-14-1, Open Meetings Act. An agenda should have been made available. Problems with compliance. The remedy for these violations is that any decisions made are void.
 - The First Amendment still applies regardless of whether GOP rules are "certified" or not. OCGA 21-2-6: BOE on its own motion can bring challenges.

 Certification. No attorney at the hearing defined "certified." Christine offered a definition by the Justia Law dictionary and explained that verifying and certifying are not the same.

Mary Beth Bugea

- o Referred the BOE to the movie "Let My People Go"
- Will provide the BOE with information on how to conduct hand counts from both Democrats and Republicans as it is not a Red vs. Blue issue.
- First Amendment Rights were denied by both Judge Thompson and the BOE.
- Problems with the 4/2 hearing: not a public hearing, challengers treated as though they were on trial, prejudice against GOP, certification definition problems.

Charlie Lamar

- BOE trampled on the First Amendment; arguments on certification superseded it.
- The deck was stacked against GOP. Attorneys should have also been sworn in. Candidates knew the rules, and the rules were valid. The judges recused themselves. It was a hearing of professionals vs. citizens. For the BOE it was a vote against the Constitution.

Nancy Dwyer

- Catoosa County GOP leaders are being persecuted.
- The vetting process was the right thing as many voters don't have time to keep up with the candidates. People depend on the GOP to do that work.
- Voters see the corruption of Catoosa County.
- As for the hearing, laws were broken and there was unfair treatment. But Jesus saw that hearing. Prov. 19:32 and Ps. 31:19,20

Jim Coles

- Concurs with everything said.
- 2022 Williamson TN: poll workers found QR Code failure and fought to investigate. Ultimately it led to the governor removing Dominion Systems.
- Mitchell Horner put forth legislation to get rid of QR codes. Jim mentioned the need for security-grade, hand-marked, hand-counted, paper ballots.
- This July, open records requests will allow average citizens to look at election results.
 - 2022 DeKalb County: Spears received no votes but won the race. This
 never would have happened on paper, hand-counted ballots.
 - Consider going to emergency procedures right now, with paper ballots in May.

Adrienne Kittle

Liberty and Freedom died at this Board's hands last week.

- CC Republican Party exercised its First Amendment right and this Board trampled on it.
- Chairman Mckelvy did not conduct the hearing fairly; there were problems with video/audio recordings and closing arguments.
- Ken Smith
 - No conflict with BOE and lawyers.
 - o Republicans divide, Democrats stick together
 - Trump won on the machines.
 - Appreciation for the board.
- Shirley Henson
 - Thankful for all in attendance.
 - o Reminded the Board that votes used to be counted on courthouse steps
 - No lawyers to represent the citizens at the 4/2 hearing. It was like a courtroom trial, with no videos etc.
