James Davis reported that he has met with the various Department Officials regarding all issues concerning the Luke Bryan concert. (Sheriff's Office, Fire Department, Public Works, Environmental Health, Building Department, Planning and Zoning). Each Departmental Official has approved the Special Event application with the exception, of the Planning and Zoning Department. A fee of \$5900.00 will be paid to Catoosa County for all services rendered. All building and stage plans have been submitted and will be inspected the morning of the event. The representative for Farm for Life did not attend due to all correspondence being in place. There will be two people at each alcohol station checking ID's. Additionally, bracelets must be worn by those who purchase beer or wine. The overall area will be lit and anyone who needs assistance, a service will be available. Golf Carts will be used to transport anyone who needs assistance. Contingencies have been put into place pertaining to inclement weather. Should anyone need assistance with vehicles, tractors will be available along with a form release if services are rendered. There will be no fireworks on the premises for this event. Any issues regarding pedestrians will be handled by the Sheriff's department. Yvonne Morgan asked if food will be sold and James Davis answered that the Environmental Health Department will be responsible for

meeting with food vendors and handling bathroom facilities. Dusty Bridges asked if the beer would be bought from wholesale retailers, James Davis was unsure but thought they would.

RV's will be allowed into the event area starting at 7am. Tailgating will be allowed prior to the event starting at 4pm.

Chairman Bridges commented that the concert will be good and helpful to the County.


