Old Business:

D&M Motorsports DBA as Boyd Speedway was tabled at the August 16th 2016 meeting. James Davis explained to the Alcohol Board Commission that He (Zoning), Rick Quarles (Building Inspector), and Kenny Slayton (D&M Motorsports) have met and all were in agreement that the requirements needed for purchasing an Alcohol License have been met. Along with this, an email from the State Fire Marshal has been received confirming their approval. Attorney Skip Patty concurred with James Davis that Boyd Speedway must also be in compliance with the ordinance regarding food sales, outside sales and seating arrangements. Attorney Skip Patty also clarified the wording issue on the court order regarding purchasing an annual license or a special event license. James Davis presented to the Alcohol Board Commission a diagram of where the outside sales area would be located. This area will be secured within a fenced area and security will be on the premises to check ID's and to ensure that no one with an alcoholic beverage will be allowed to leave the premises. The entrance gate to the beer garden area is six

(6) feet but there is an additional gate that can swing back to make a total of twelve (12) feet in case of emergencies. Chairman Bridges asked where food would be sold and James Davis commented that the food trailer will be kept in the same area as the outside sales area. The food will be prepared then transferred to the food trailer. Ernest Pursley asked Attorney Skip Patty about the modification of the court order and Attorney Skip Patty explained that both Judge Van Pelt and the District Attorney both approved the court order but the owners must stay in compliance of Catoosa County ordinances.

Motion was made by Ernest Pursley to approve D&M Motorsports DBA Boys Speedway. Yvonne Morgan seconded the motion.
